## To Whom It May Concern:

The University of Georgia Executive Master of Business Administration (EMBA) is a flat-fee cost structure program as approved by the University System of Georgia Board of Regents (BOR). The total flat-fee cost covers the entire program's tuition and select mandatory University registration fees, select course materials (i.e., simulations, case study packets), professional development co-curricular programming, executive coaching, meals during class weekends, two domestic one week residencies, and one international residency (minus airfare and visa costs). The fees included in the EMBA tuition DO NOT include textbooks, other student fees such as student activity, student center, athletic, recreation, health or transportation and are not part of the total cost of the program.

The program is 18-months or five consecutive semesters in length and consists of 17 courses taught in 10 modules and an international residency. The delivery is lock-step cohort with a fixed schedule where students begin as a class and complete the program together. The flat-fee structure bundles costs associated with the program and payments are charged in five equal installments spread across the five semesters. The seat deposit of \$1,000 is applied to the first payment. The total cost for students in the class matriculating 2023-2025 is \$74,750 for Georgia and non-Georgia residents.
